The Climate Change Agreement scheme is closing to new applications on the 30th of November 2020.

Have you checked your eligibility?

What is a CCA or Climate Change Agreement

Climate change agreements are voluntary agreements made by UK industry and the Environment Agency to reduce energy use and carbon dioxide (CO2) emissions. In return, operators receive a discount on the Climate Change Levy (CCL), a tax added to electricity and fuel bills. The Environment Agency administers the CCA scheme on behalf of the whole of the UK. — www.gov.co.uk

Sector Associations negotiate an umbrella agreement between The Department for Business, Energy, and Industrial Strategy (BEIS) and the sector. An underlying agreement is then applied for via the sector association for all sites that wish to benefit from the CCL and commit to the targets put in place.

The current CCA scheme has been in operation since April 2013 and will run until March 31st, 2023 but at present under current guidelines will close to new entrants on the 30th of November 2020.

Does your industry or sector have a CCA?

At present there are 50+ sectors that have negotiated and implemented umbrella agreements. Eyebright will be happy to advise if your sector has an umbrella agreement in place.

Is the CCA open to new applications?

At present all CCA's are open to new applications but this is due to change on the 30th of November 2020. Eyebright will be happy to clarify the relevant dates for your sectors CCA umbrella agreement.
